## Personal data administrator and processor

## PERSONAL DATA PROCESSED BASED ON APPROVAL

### Data in the lists of competitors and score sheets

- Name and surname

Data procession is based on the agreement given by the competitor in the application form for these reasons: Publishing of the list of competitors (the order of the performances), score lists of the both rounds, schedule of the rehearsals with the competition official competitors. The lists above and published before the competition, during the competition and the only exception are the final score lists, which are published for the period of 10 years after the end of the competition. The lists and schedules are published on our websites and in printed version in the buildings where the competition take place. The list of competitors is a part of a publicly distributed printed bulletin.

If the competitor does not give the agreement or withdraw the agreement for his/her name to be published in the lists and score, the name will be replaced by the registration number. This replacement cannot be taken back in the printed medias.

### Agreement to provide the data to the third part – accommodation providers

- Name and surname
- Date of birth
- Permanent residence address
- ID number/ EU ID card or passport

The data above are processed based on the agreement given by the provider in the application form for the accommodation and we provide them to the third part – accommodation provider.

In case you do not give your agreement, we cannot help with accommodation.
